Background Information	<ul> <li>In June 2024, Waste Management (WM) notified staff of their intent to renegotiate and amend the current Municipal Solid Waste Agreement, which was approved in May 2019 (Attachment A). Staff opted to work directly with WM rather than pursuing other providers due to:</li> <li>WM's consistent, high-quality service and collaborative relationship with the City.</li> <li>A 30-year partnership between the City and WM.</li> <li>Positive public feedback, with Garbage Collection receiving a 91% "Good" or "Excellent/Very Good" rating in the 2021 Citizen Survey and a 96% "Ok/Good/Very Good" rating in 2023.</li> </ul>
	<ul> <li>WM has proposed rate increases for both residential and commercial customers, citing rising material and operational costs due to COVID-19 and inflation. The new rates are competitive with those of other municipalities and maintain Boerne's high level of service (Attachment B).</li> <li>Enhancements to Service: After the Council's November 12 discussion, staff worked with WM to address concerns, resulting in the following negotiated improvements:</li> </ul>
	<ol> <li>Same-Day Service:         <ul> <li>All customers will receive garbage and recycling collection on the same day.</li> <li>WM will purchase an additional truck to support this, increasing monthly costs by only \$1.</li> </ul> </li> <li>Senior Discount:</li> </ol>

	<ul> <li>Seniors 65 and older can apply for a 10% base rate discount on trash service.</li> </ul>
