SUMMARY	<p>Please refer to the background information provided in the previous summary. 131 Old San Antonio is a 6 ½ acre lot that houses Texas Ten Oaks Storage and a small grave yard in the middle of the storage facility. They have recently been annexed and therefore require permanent zoning. The current use is an industrial type use. This property is located across the street from the South Industrial Park and next to Alamo Gage and the future Vantage Apartments.</p> <p>Council voted unanimously to zone the property B-2R. Staff is supportive of the commercial zoning.</p>
