SUMMARY	We entered into a Development Agreement with the Hill Country Daily Bread organization a while ago. The crux of the agreement was that we would allow them to extend a water main to their property and have the use of water even though they were not located in the city limits at that time, with the provision that when their property became contiguous to the city limits they would submit a petition for annexation.
	We have just completed the annexation of the Currey Creek Baptist Church property which is across from the Daily Bread property on Cascade Caverns Road.
