1. CALL TO ORDER – 11:30 AM.

Mayor Schultz called the City Council to order at 11:30 AM.

2. WELCOME

Patrick Cohoon, Chairman of the Greater Boerne Chamber of Commerce welcomed the audience to the State of the City address. Mr. Cohoon introduced Mayor Schultz.
