#### 1. CALL TO ORDER – 4:30 PM

Mayor Schultz called the City Council to order at 4:30 p.m.

#### 2.A. WORKSHOP DISCUSSION:

# A. Discussion On Proposed Senior Living Rental Housing

Mayor Schultz called on Mr. Chris Turk, Planning and Community Development Director. Mr. Turk introduced Mr. Brett Johnson of the Overland Property Group (OPG). Mr. Johnson displayed the rental units they have developed in five states including six communities in Texas. They currently do not have a property location in Boerne but are focusing North of Adler Street. Mr. Johnson explained that the proposed Resolution does not commit the City to the project but affirms the City's support for an application to the Texas Department of Housing and Community Affairs for 2016 Low Income Housing Tax Credit Program.

# 2.B. WORKSHOP DISCUSSION:

#### **B. Discussion On Space Needs Assessment**

Mayor Schultz called on Ms. Linda Zartler, Assistant City Manager to discuss the Space Needs Assessment for the City Council Chambers and the Executive Session area for the proposed new City Hall facilities. Ms. Zartler introduced Randall Scott, Preston Scott, and Greg Conaway of Randall Scott Architects. She asked for City Council input on how the Council Chambers and Executive Session room should look and operate. Ms. Zartler asked Mr. Mike Raute, Information Technology Director to discuss the technology available for a new City Council Chambers. Discussion ensued regarding whether the Boards and Commissions will also be using the new Chambers or remain in the current facility; angle of the dais and additional seating for future growth; seating for senior staff; seating for audience to accommodate growth and overflow; security, improve acoustics; types of seating for the audience; using the room as a multi-function space; private office area of Council Members; additional isles for the audience to access seating; finances; take into consideration ever-changing technology; and have a round table in the Executive Session room with a kitchen area and restrooms. Mr. Scott reviewed his experience with other city's facilities and stated that cities are putting a monitor in the podium as well as built-in monitors at the dais and projection at the back of the room only. Staff typically is seated at one side of the room. He stated that his firm met with City Staff today and provided a questionnaire to the department heads to help his firm determine department needs.

#### **3. PUBLIC COMMENTS:**

Karl Gramm, 125 Well Springs stated he has been with United Parcel Service (UPS) for 36 years. With holidays fast approaching, it is anticipated that package delivery will double after November 15, 2015. He spoke to Agenda Item 14, permitting golf carts on certain public streets. He stated that seven golf carts can eliminate five UPS trucks and improves pickup and delivery for residents and local businesses. The golf cart drivers would be dressed in brown color uniforms, would not exceed 20 mph and are trained seasonal employees and are Boerne residents. The operating hours would be from 10:00 a.m. to 4:00 p.m. daily. There have not been any accidents in the last four years UPS has used golf carts.

Jody Daniel, 208 Yoalana Street stated that his wife has Multiple Sclerosis and allowing golf carts would be a benefit to her to get around Boerne. After much research, he found that the biggest safety issue with golf carts is people falling out of the golf carts because they are not using seat belts. With certain restrictions, he feels that golf carts would improve the quality of life.

Mayor Schultz called on Mr. Chris Turk, Planning and Community Development Director. Mr. Turk displayed the location of the existing Murphy Oil USA Inc. gas station which is located in front of WalMart. He explained that the owners plan to demolish the existing building and construct a new building on the same site as well as add additional gas pumps. The Planning and Zoning Commission made the recommendation that the City Council approve the use of an automobile gas station in a B-2, Highway Commercial District for 1381 South Main Street with the caveat that the canopy be comprised of a textured surface and not an aluminum wrap, that the illuminated sign be white and not red, the facade be rock, and increase landscaping to shield visibility of the gas station. Staff recommended approval of Ordinance No. 2015-40 with the Planning and Zoning recommendations. Discussion ensued regarding the signage, pricing, and number of pump islands.

Mayor Schultz called on Mr. Mark Mattick, Fire Marshal. Mr. Mattick stated that when the City Lake Dam was built, the City of Boerne signed an agreement with Natural Resource Conservation Service (NRCS) stating that the City would be responsible for the maintenance of the City Lake Dam which includes brush removal. The City secured a 90/10 grant up to \$30,000 through NRCS to remove the brush off of the dam site. The City received three bids with Langeberg Specialty Services being the low bidder at \$27,000. NRCS will reimburse the City after the work is complete. Staff recommended entering into an agreement with Langeberg Specialty Services for brush clearing at the Boerne City Lake Dam site.

Mr. Turk discussed the scope of the study with the two property owners who both agreed to share the cost of the study. Discussion ensued regarding the consequence of current businesses in the 100 year flood plain. Staff recommended approval of Resolution No. 2015-R112 entering into an agreement with Kimley-Horn and Associates in the amount of \$51,500.00.

Section 7.10 regarding "on call" or "standby" - each department has specific needs and will establish rules based on the department. Effective September 1, 2015, House Bill 786 requires public employers to have a written policy on the expression of breast milk by employees and Section 18 pertains to Travel and Subsistence. Staff recommended approval of the proposed Personnel Policies changes.

Mayor Schultz called on Mr. Mike Mann, Public Works Director. Mr. Mann explained that the City has operated it's water supply wells under a permit from the Cow Creek Groundwater Conservation District (CCGCD) since 2007. The permit allows a maximum withdrawal amount of 1,850 acre-feet from any combined production from the various City wells. The Permit requires that the City submit a proposed Quarterly Scheduled Withdrawal Amount every year. Staff recommends that the City Council retain the current quarterly percentage allocation of groundwater of 370, 555, 555, 370 acre-feet for 1st through 4<sup>th</sup> quarter for calendar year 2016.

Mr. Barwick stated that Amphitheater project's initial completion date was June 5, 2015 but due to rain days the completion date was extended to September 15, 2015. During a welding inspection, it was determined that the field welds had failed. The Contractor spoke with several fabrication shops and secured a fabricator for the replacement structure. The estimated Project substantial completion date was to be October 26, 2015. Currently, it is expected that the Project will be completed by the end of November 2015. Mr. Barwick displayed a photo of the current status of the amphitheater, bathroom and indicated the placement location of the two sculptures donated by the Majestic Ranch Arts Foundation.
