| <b>SUMMARY</b>  | <p>At the Quarterly Round Table meeting in July, Council requested that I prepare an ordinance pertaining to the use of portable electronic devices while driving. At the Quarterly Round Table meeting, we discussed other nearby city ordinances and a proposed draft.</p> <p>During the first reading, discussions were held concerning the portion of the Ordinance prohibiting the use of a portable electronic device while operating a bicycle. Upon further discussion with the City Manager, it was requested that this provision be removed from the Ordinance. The provision prohibiting the use of a portable electronic device while operating a bicycle was removed from the Ordinance.</p> <p>Please remember, should the Council decide to pass the ordinance, it would become effective January 1, 2016, with citation warnings being issued for 30 days to educate the public. A citation under the ordinance is not a moving violation.</p> |
