HOLD A PUBLIC HEARING AND CONSIDER A REQUEST FOR A DEMOLITION PERMIT FOR THE ACCESSORY STRUCTURE(S) LOCATED AT 402 HERFF STREET.

Benjamin "Ben" Simmons, Planner I, presented the proposed accessory structure demolition request.

Vice-Chair Graves opened the public hearing at 5:32p.m. The public hearing was closed at 5:35p.m.

Twenty-four notifications were mailed to properties within 200ft of the property and it was noticed in the Boerne Star. Two written responses were received in favor of the demolition.

Vice-Chair Graves commented on her site visit, stating that the structure is in bad shape.

Commissioner Wright noted that demolishing the structure is better for public safety.

Foster Simonsen, Planning Intern, presented the proposed sign.

Commissioner Wright stated that the Richter sign is a similar style, and asked if there are other illuminated signs in the area which HLC agreed with. Commissioner Nichols stated that this is one of his favorite buildings in Boerne and recalled previous discussions about painting the sign on the building. He continued by stating his preference to continue having a painted sign. Kelly Mattingly, the applicant, stated that the design will appear very standard during the day, but will have less light shining down at night. Commissioner Nichols asked for clarification on which lights will be removed. James Shobach, the property owner, stated that the intent is to clean up the sign clutter and all the downlights will be removed. Commissioner Mainz asked if all three signs and downlighting will be removed. Mr. Shobach Confirmed they would be. Commissioner Nichols restated that a painted sign is more appropriate for the building design. Commissioner Wright stated that the building is a French revival style and the sign is more art deco.
