Background Information	The City of Boerne and Friends of the Cibolo Wilderness first entered a ten-year operations agreement in 1996 for the area known as the Cibolo Nature Center. The agreement was extended in 2006 and is set to expire in 2026. This contract calls for both parties to begin negotiations five years before the expiration. Staff and representatives from the Friends of the Cibolo Wilderness have been working cooperatively on the renewal agreement.	
	The proposed agreement is a twenty-five-year lease with negotiations for renewal starting ten years before expiration. This extended renewal window was requested to help secure grants and donations and ensure adequate time to negotiate the continued operations of the nature center. Additionally, language and exhibits are included to identify and acknowledge the importance of key features, including riparian zones, the tree tunnel along City Park Road, and Herff Springs.	
	Exhibit B is the Operations and Maintenance agreement outlining shared responsibilities for the public portions of the park. This agreement is renewed every five years to account for the changing needs of the City of Boerne and the Friends of the Cibolo Wilderness.
