

ORDINANCE NO. 2023-21

AN ORDINANCE AUTHORIZING THE INSTALLATION OF STOP SIGNS AND YIELD SIGNS FOR THE FOLLOWING SUBDIVISIONS: SHORELINE PARK PHASE 1, SHORELINE PARK PHASE 2, SHORELINE PARK PHASE 3 AND 4, REGENT PARK UNIT 4; PROVIDING FOR A PENALTY NOT TO EXCEED \$200 FOR EACH VIOLATION OF THIS ORDINANCE; AND PROVIDING FOR PUBLICATION

WHEREAS, pursuant to Texas Transportation Code Section 544.003, the City Council of the City of Boerne is authorized to designate an intersection on a highway under its jurisdiction as a stop and yield intersection and place a sign at one or more entrances to the intersection; and

WHEREAS, the City Council, after deliberation, deems it necessary to install stop and yield signs in certain areas of city streets to promote the public health, safety and general welfare of the citizens and visitors of the City of Boerne.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BOERNE, TEXAS:

Section 1. Stop signs shall be installed for Shoreline Park Phase 1:

1. Intersection of Aqua Shores and Ranger Creek
 - a. Southbound on Aqua Shores
2. Intersection of Granite Shores and Aqua Shores
 - a. Westbound on Granite Shores
3. Intersection of Flowing River and Aqua Shores
 - a. Westbound on Flowing River

Section 2. Stop Signs for Shoreline Park Phase 2:

1. Intersection of Sambar Bay and Ranger Creek
 - a. Southbound on Sambar Bay
2. Intersection of West Granite Shores and Sambar Bay
 - a. Westbound on West Granite Shores
3. Intersection of West Granite Shores and Aqua Shores
 - a. Eastbound on West Granite Shores

Section 3. Stop Signs for Shoreline Park Phase 3 and 4:

1. Intersection of West Flowing River and Sambar Bay
 - a. Westbound on West Flowing River
2. Intersection of West Flowing River and Aqua Shores
 - a. Eastbound on West Flowing River
3. Intersection of Open Puddle Lane and West Low Cascade
 - a. Southbound on Open Puddle Lane

Section 4. Stop and Yield Signs for Regent Park Unit 4

1. Intersection of Balmoral Place and Regent Park
 - a. Southbound on Balmoral Place
2. Intersection of Balmoral Place and Huntwick
 - a. Northbound on Balmoral Place
3. Intersection of Huntwick and Haverton
 - a. 3 yield signs at the roundabout

4. Intersection of Beaver Bend and Huntwick
 - a. Eastbound on Beaver Bend
5. Intersection of Bretford and Huntwick
 - a. Southbound on Bretford

Section 5. Violation of this ordinance shall be punishable with a maximum fine not to exceed \$200 for each violation.

Section 6. The City Secretary is hereby authorized and directed to publish the caption in the newspaper as provided by law.
