| SUMMARY | <p>Over the past few years, the City has established various “No Parking” zones adjacent to Fabra Elementary School in its former location between Johns and Lohmann. Now that Fabra Elementary has been relocated, we understand the School District is re-purposing the campus as administrative offices and an alternative school campus. Middle School North will also still remain in operation across Johns Road.</p> <p>The School District has requested that we remove all parking restrictions along the south side of Johns Road and the north side of Lohmann Street to better facilitate their needs. They have already removed all of the signage along the south side of Johns Road in anticipation of the City granting this request.</p> <p>Staff has no objection to the removal of the parking restrictions as requested.</p> |
