ORDINANCE NO. 2016-29

AN ORDINANCE REPEALING AND REPLACING ORDINANCE NOS. 2009-41, 2010-27, 2011-12, 2011-25, 2012-18, 2012-31, 2015-19, AND 2015-27, ESTABLISHING THE DESIGNATION OF NO PARKING AREAS WITHIN THE CITY OF BOERNE; AND PROVIDING FOR A PENALTY OF NOT MORE THAN \$200 FOR EACH VIOLATION

WHEREAS, from time to time it becomes necessary to repeal and replace ordinances; and

WHEREAS, traffic surveys and informal observation have indicated continuing traffic hazards on various streets within the City of Boerne; and

WHEREAS, the City Council, after deliberation, deems it necessary to prohibit the parking of vehicles on certain areas of city streets to promote the public health, safety and general welfare of the citizens and visitors of the City of Boerne;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BOERNE, TEXAS:

<u>Section 1.</u> It shall be prohibited to park at any time of the day or night at a curb or on a street that has been designated a no parking area by either a yellow painted curb or an official posted sign.

<u>Section 2.</u> The following are hereby designated no parking areas:

- a. South side of River Road from South Main Street to Esser Road, with the exception of parallel parking to be permitted between Pecan Street and the Cibolo Creek Dam
- b. Both sides of South Main Street from Bandera Road to River Road
- c. West curb of North Main Street from San Antonio Avenue to Lohmann Street. The east side of North Main Street from San Antonio Avenue a distance of two hundred (200') feet north of Blanco Road
- d. North side of Bentwood Drive from Esser Road a distance of six hundred (600') feet east
- e. South side of Bentwood Drive from a point six hundred (600') feet east from Esser Road to a point one thousand nine hundred (1900') feet east from Esser Road
- f. East Theissen Street from one hundred (100') feet east of the Theissen Street Cibolo Creek Crossing to one hundred ninety five (195') feet west of the Theissen Street Cibolo Creek Crossing
- g. Parking shall be prohibited and traffic regulated as indicated below:
 - i. Prohibit U-turns on Johns Road between Main Street and School Street at all times.
 - ii. Establish bus zones by prohibiting parking on the south side of Johns Road from a point approximately 340 feet east of School Street to run for a distance of approximately 300 feet, and on the east side of School Street from the intersection of Schleicher south for a distance of approximately 250 feet on school days from 7:00 a.m. to 4:30 p.m.

- iii. Establish no parking on school days from 7:00 a.m. to 4:30 p.m. on the north side of Johns Road from a point 400 feet west of the intersection of Live Oak to continue west 20 feet east of School Street.
- iv. Establish no parking on the west side of School Street from Johns Road north to Schleicher Street and on the east side from a point approximately 80 feet north of Johns Road to run for a distance of 100 feet.
- v. Establish a no parking or stopping area on school days only from 7 a.m. 9 a.m. and 2 p.m. 4:30 p.m. on the south side of Johns Road from a point approximately 170 feet east of School Street to run for a distance of approximately 170 feet.
- vi. Establish no parking on school days from 7:00 a.m. to 4:30 p.m. on the south side of Johns Road from the intersection of School Street east for a distance of 170 feet.
- vii. Two hour parking on school days 7:00 a.m. to 4:30 p.m. on the south side of the 100 block of Bentwood for a distance of 400 feet east of Esser Road, and no parking at any time from that point 400 feet east of Esser Road for an additional 300 feet.
- h. The north and south curbs of East Blanco Road from the intersection of Main Street to the intersection of Esser Road.
- i. The west curb of the 400 block of South Main Street for a distance of 235 feet north of River Road at all times
- j. The 400 block of North School Street on the east and west sides
- k. South Main Street for a distance of forty (40') feet southeast of the southeastern right-of-way line of San Antonio Avenue
- I. Sixty (60') feet along the north curb line of West San Antonio Street from One Main Plaza towards Main Street
- m. Sixty (60') feet along the south curb line of West Blanco Road from One Main Plaza towards Main Street
- n. Fifty (50') feet along the east curb line on One Main Plaza north from West San Antonio Street
- o. Twenty (20') feet south along the east side of South Main Street from Theissen Street southward
- p. Twenty (20') feet south along the west side of South Main Street from Theissen Street southward
- q. Twenty (20') feet north along the west curb of South Main Street from Theissen Street northward
- r. Twenty (20') feet north along the east curb of South Main Street from James Street northward
- s. Thirty (30') feet along the south curb of West San Antonio Street starting at the east curb line of the west entrance/exit at 115 West San Antonio Street and forty (40') feet west along the south curb of West San Antonio Street at the west entrance/exit at 115 West San Antonio Street
- t. Parking shall be prohibited and traffic regulated as indicated below:

- viii. A designated "Emergency Vehicle Only" parking area on the south side of San Antonio Street extending from the intersection of the access road on the west side of the Kendall County Courthouse and San Antonio Street to the west boundary of the sidewalk leading to the north entrance to the Kendall County Courthouse.
- ix. Extension of the "No Parking" Zone on the west side of Saunders Street from the North Boundary of the entrance to the parking area on the East side of the Kendall County Courthouse for an additional ten (10) feet. Extension of the "No Parking" Zone on the west side of Saunders Street from the intersection with San Antonio Street so that the total no parking areas measures twenty-five (25) feet. (Extension of these "No Parking" areas is necessary to allow operators of vehicles exiting the parking areas of the Kendall County Courthouse to Saunders Street and stopped at the intersection of San Antonio Street and Saunders Street sufficient line of sight to avoid traffic along Saunders Street.).
- u. Main Street from Blanco Road to Schleicher.
- v. South side of Ryan Street.
- w. South side of the 1600 block of River Road from the intersection with Charger Blvd east for 0.28 miles.
- x. Off pavement parking on the north side of the north curb in the 100 block of Deer Creek for a distance of 500 feet east of Esser Road.
- y. City Park Road from 185 feet northwest to 265 feet southeast of Champion Boulevard.
- z. North side of Lohmann Street (120 linear feet beginning 480 feet east of School Street) between the hours of 7:00 a.m. and 8:00 a.m., and 2:00 p.m. and 4:00 p.m. on school days.
- aa.z. North side of Rosewood Avenue from Plant Street to Stahl Street.

Section 3. The following are hereby designated no parking, standing or stopping areas:

- a. Both sides of Commercial Drive from the parking lot of Kendall County Annex Building (221 Fawn Valley Drive) to Fawn Valley Drive.
- b. South side of Fawn Valley between Commercial Drive and Esser.

<u>Section 3 4.</u> Violation of this ordinance shall be punishable with a maximum fine not to exceed \$200 for each violation.
