1. CALL TO ORDER – 5:15 PM

Mayor Schultz called the City Council to order at 5:20 p.m.

Mayor Schultz asked for a Moment of Silence and led the Pledge of Allegiance to the United States Flag and to the Texas Flag.

Mayor Schultz opened the Public Hearing at 5:22 p.m.

3A. [2016-830](#) PROPOSED BUDGET FOR FY 2016-2017 (Vote on proposed budget to be held at Regular City Council Meeting at the City Council Chambers on September 13 at 6:00 PM.)

No public comments were received.

Mayor Schultz called on Ms. Sandy Mattick, Finance Director. Ms. Mattick stated as part of the 2016-2017 budget process, it is a requirement to hold one Public Hearing. The total proposed budget amounts to \$63,760,908 and includes the proposed tax rate of \$0.4720/\$100 valuation. The first reading of the Ordinance to approve the budget will take place later in the agenda. The second reading of the Ordinance will be considered at the September 13, 2016 Regular City Council meeting at 6:00 p.m.

Mayor Schultz closed the Public Hearing at 5:23 p.m.

3B. [2016-829](#) PROPOSED TAX RATE FOR FY 2016-2017 (0.4720/\$100) (Second Of Two Hearings, final vote on proposed tax rate will be held at Regular City Council Meeting on September 13 at 6:00 PM.)

Mayor Schultz opened the Public Hearing at 5:23 p.m.

No public comments were received.

Ms. Mattick continued with the proposed tax rate for FY 2017. She stated that as part of the process, two public hearings must be held. The first public hearing was held on August 23, 2016. The proposed tax rate for FY 2017 is \$.4720 per \$100 valuation which is the same rate as FY 2016. Consideration to approve the Tax Rate will be held at the Regular City Council Meeting of September 13, 2016 at 6:00 p.m.
