

ORDINANCE NO. 2017-11

AN ORDINANCE REPEALING AND REPLACING ORDINANCE NOS. 2016-30, 2016-28, 2012-46, 2009-42, 2008-29, 2008-23, 2008-18, AND 2006-04 AND AMENDING THE CODE OF ORDINANCES, CITY OF BOERNE, TEXAS, BY AMENDING CHAPTER 12. MOTOR VEHICLES AND TRAFFIC, ARTICLE VII. SCHOOL ZONES, DIVISION 1. GENERALLY, SECTION 12-206. ESTABLISHED, SECTION 12-208. PASSING PROHIBITED, SECTION 12-209. U-TURNS PROHIBITED AND SECTION 12-210. SIGNS; AND PROVIDING FOR A PENALTY NOT TO EXCEED \$200 FOR EACH VIOLATION

WHEREAS, it becomes necessary, from time to time, to amend ordinances and/or resolutions in the interest of the citizens; and repealing and replacing Ordinance Nos. 2016-30, 2016-28, 2012-46, 2009-42, 2008-29, 2008-23, 2008-18, AND 2006-04

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BOERNE, TEXAS:

SECTION I.

Chapter 12. Motor Vehicles and Traffic, Article VII. School Zones, Division 1. Generally Section 12-206. Established. of the Code of Ordinances, City of Boerne, Texas is hereby amended to read as follows:

SECTION 12-206. - Established

Speed reduced speed limits, where applicable, in school zones shall be twenty-five (25) miles per hour.

(1) "School Zones," between the hours of 7:00 a.m. and 9:00 a.m. and 2:30 p.m. and 4:30 p.m., on school days only, shall be established at the following locations:

~~Johns Road 1,050 feet west of Lattimore Boulevard to 50 feet east of Lattimore Boulevard and on Lattimore Boulevard 150 feet south of Chisholm Drive to 300 feet south of Johns Road;~~

~~Old San Antonio Road seven hundred (700) linear feet and centered about one thousand two hundred eighty (1,280) feet north of Cascade Caverns Road intersection and on Cascade Caverns Road three hundred forty (340) linear feet and centered about six hundred twenty (620) feet east of the Old San Antonio Road intersection.~~

~~Approximately 350 feet northwest of the intersection of Old San Antonio Road and Industrial Drive and continue northwest on Old San Antonio Road for approximately 875 feet;~~

~~Adler Road 400 feet west of the west school property line to approximately 400 feet east of Plant Street;~~

~~Plant Street from the intersection with Adler Road to approximately 400 feet south of the south school property line;~~

~~Lohmann Street from Main Street to School Street;~~

~~Schleicher Street from Live Oak to School Street;~~

~~Live Oak from Schleicher to Johns Road;~~

~~Whole length of Charger Blvd.~~

~~Herff Ranch Blvd. from approximately 300 feet north of the north school property to 300 feet south of the south school property line;~~

~~On Desert Flower approximately 300 feet east of the intersection with Herff Ranch Blvd.;~~

~~(2) "School zones," between the hours of 7:00 a.m. and 9:00 a.m. and 2:00 p.m. and 4:30 p.m., on school days only, shall be established at the following locations:~~

~~Charger Blvd. one hundred (100) feet south of Highway 46 and one hundred (100) feet north of City Park Road;~~

~~Johns Road from Main Street to four hundred (400) feet west of the west school property line on Johns Road;~~

~~School Street from four hundred (400) feet south of Lohmann Street to four hundred (400) feet north of Schleicher Street;~~

SECTION 12-208. PASSING PROHIBITED

It shall be unlawful for the driver of a vehicle to overtake and pass another vehicle (while school zones are effective) on the streets within or serving the School Zone as named in Section 12-206 of this ordinance.

SECTION 12-209. U-TURNS PROHIBITED

U-turns shall be prohibited (unlawful to turn a vehicle so as to proceed in the opposite direction) ~~on Johns Road~~ in all School Zones during the effective hours.

SECTION 12-210. SIGNS

Appropriate signage shall be placed, erected and installed at each entrance to the area described in the terms of this article at a place clearly visible to any ordinarily observant driver of a vehicle which shall give notice of the restrictions imposed by the terms of this article.

SECTION II.

Violation of this ordinance is a misdemeanor and shall be punishable by a fine not to exceed \$200.00 as authorized by State Law including, but not limited to those contained in the Texas Transportation Code.

This ordinance shall be published in accordance with the requirements of publishing all ordinances and becomes effective upon publication in accordance with state law.
