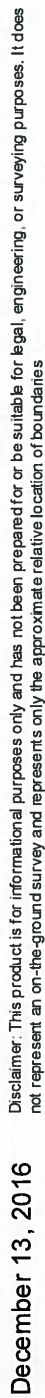

Wendler, of the County of Kendall, and State of Texas;

All my undivided interest in all that certain tract, piece or parcel of land being a part of the A. Cruz survey No. 170 in Kendall County, Texas, situated on the waters of the Balcones Creek about four (4) miles south of Boerne, Beginning at the southeast corner of a 1147 acre tract out of said survey No. 170 sold to Paul Sueltenfuss by Adolph Wendler and Henry Wendler and being the N.E. corner of this tract said corner is in the center of the Balcones Creek L.O. 10" S. 89 $\frac{1}{2}$ " W. 10 vs. Thence S. 89° 30' W. 381 varas to a post in fence line for corner, Thence S. 83° W. 248 varas to S.W. corner of 1147 acre tract in the east line of the Wm. FIRST TRACT: Being Lot Number Sixteen (16) in Graham's Addition to the town of Boerne,
