H. Budget Calendar**1. Status Update**

Mayor Schultz called on Ms. Sandy Mattick, Finance Director. Ms. Mattick stated that Staff is currently working on Draft 3 of the proposed budget. She discussed the increased cost of employee health insurance which affects all funds. She reviewed the adjustments made to the General Fund, Electric Fund, Water Fund, Wastewater Fund, and Gas Fund. She reviewed the 2017 average residential values, property tax rate history from year 2003 to present, and police and fire expenditures. Ms. Mattick reported that 95% of the ad valorem tax revenues are applied to the police and fire expenditures. Discussion ensued regarding the GBRA water rate increase due to the required water treatment. Mr. Mike Mann, Public Works Director explained that the increased amount is an assumption and the amount may vary each year. Mayor Schultz stated that he will be meeting with Kendall County Judge Darrel Lux to discuss the inter-local agreements. City Manager Ron Bowman explained the formula used to determine the cost sharing between Kendall County and the City for

fire services. Ms. Mattick displayed the proposed General Fund Budget graph indicating the makeup of the city departments.

Assistant City Manager Linda Zartler discussed the employee health insurance. She stated that a 20% rate increase is expected due to a high loss ratio. She explained that the City currently pays 100% of the employee only coverage and 40% of dependent coverage. She discussed the proposed two plans to be offered to the employees next fiscal year. Discussion ensued regarding the current plan and proposed high deductible plan and the cost associated with each. A suggestion was made to shop the rates to include all types of plans and making the high deductible plan the Core plan and allowing employees to buy up if they wish to enroll in a more expensive plan.

Fire Chief Meckel spoke on the fire service inter-local agreement with Kendall County. The City is proposing that the County pay the same per rooftop as in FY 2016-2017 using the new count of rooftops.

Ms. Zartler discussed the inter-local agreement for Library Services and explained that the Patrick Heath Public Library is part of the Kendall County Library Fund. Although the City is proposing an \$11,000 increase, Kendall County is proposing \$8,000.00.

Ms. Zartler continued with Sanitarian Services. Kendall County provides the service to the City and splits a 50/50 cost for services although 143 permits were issued in the City and 94 were issued in Kendall County. Staff compared costs as if the City had their own Sanitarian Department. The cost to the city would be more expensive than what is proposed at this time. Mayor Schultz informed the City Council of the desire of Fair Oaks Ranch to share a Sanitarian for the next budget year.

Police Chief Jim Kohler discussed the inter-local agreement for Dispatch services. The agreement is proportionate to the various entities involved.

Community Services Director, Danny Zincke spoke on Parks Services. Kendall County currently does not contribute to the Parks Services. Mr. Zincke reviewed the fee schedule to include non-city and non-county residents.

Discussion ensued regarding the fee charged to enter the Boerne City Lake Park. Mr. Zincke explained that the fee charged is a parking fee not an entrance fee. It was suggested that a fee be charged depending on the size of the vehicle, one or two axles.

Special Projects Director Paul Barwick discussed downtown parking and displayed a map of various potential parking areas to include the Kendall County Courthouse parking and Main Street property.

Ms. Mattick reviewed proposed changes to water, electric, wastewater, and gas rates.

Jeff Thompson, Deputy City Manager discussed the possible issuance of tax notes for the Herff Road extension and connector bridge at Menger Creek and the new city hall. He also discussed a possible future bond issue for potential street, curb, sidewalk, drainage, and park projects. Discussion ensued regarding priority sidewalk locations.

Ms. Mattick stated that Staff has received the certified tax values. She reviewed the Budget calendar, noting the required meeting dates in August necessary to adopt the budget and tax rate.

Mayor Schultz called on Ms. Linda Zartler, Assistant City Manager. Ms. Zartler reminded the City Council of the recent appointment of the City Hall Advisory

Committee. Mayor Schultz recognized the Committee Members in the audience. Mr. Jeff Haberstroh, Chair of the Committee presented the two objectives of which the committee was tasked with. He discussed the need for the proposed new facility, the results of the multiple space need assessments that have been conducted over the years, Boerne's growth rate over the last five years, and the estimated growth through 2052. Mr. Haberstroh reported that a review of comparable cities with recent built facilities was made and compared size by full time equivalent employees. He also discussed construction trends and building code standards which could raise the cost of construction. In review of the current plans, the Committee determined that office areas are adequately planned, that construction costs continue to climb annually, the project budget is in line with comps, the Construction Manager at Risk should go out for bids soon, the building is too small and is ultra conservative, and that City Council should move forward with the project and resolve the funding solution as soon as possible. The Committee suggested that the 2015 Energy Code be evaluated, that there is no need for sustainable certifications, discussion is needed for building efficiencies related to USF, the suggestion to establish a cost saving charrette, and conduct a labor wage study. Mayor Schultz expressed his appreciation to the Committee and Staff. Mayor Schultz asked that Staff bring tax note information to City Council at the August 8, 2017 meeting for action.

The Electric revenues were at 72.16% of budget and expenses were below projections at 68.95%. The Water revenues were at 76.77% of budget and expenses were below projections at 61.06%. The Wastewater revenues were at 76.94% of budget and expenses were below projections at 66.29%. The Gas revenues were at 73.98% of budget and expenses were below projections at 71.85%. Ms. Mattick reviewed the Quarterly Investment Report. She stated that the Public Funds Investment Act requires that the investment report be presented to City Council at least quarterly. The City of Boerne invested in TexPool, MBIA, Texas TERM, TexStar, Government Agencies, municipal bonds, commercial paper and several Certificates of Deposit. Interest earned for the quarter totaled \$108,886. Staff will continue to monitor interest rate activity and act accordingly when opportunities arise and in keeping with our investment policy requirements.
