Schultz called on Mr. Danny Zincke, Community Services Director. Mr. Texas Amateur Athletic Zincke explained that the Federation (TAAF) is 1925 to nonprofict organization established in promote, organize conduct and amateur athletics in the state of Texas. The City of Boerne has been a member Mr. Zincke introduced Mr. Mark Lord, Executive Director of TAAF. stated that there are currently 165 cities that are members of TAAF. Each year the members of TAAF vote on the Member City of the Year. This is the highest award given by TAAF to a member city. This is the third year that Boerne Parks and Recreation has been awarded this honor. The award is given based on the overall representation of Boerne across the state. The Recreation department also received the Platinum and City award which Boerne was one of three cities that received the award. This is the third year in a row that Boerne has received the Platinum City award. Mr. Zincke stated that it takes staff's participation in the events to win the award. He introduced and expressed his appreciation to the **Parks** and Recreation staff members in attendance.
