1. CALL TO ORDER - 4:00 PM

Mayor Schultz called the City Council Workshop to order at 4:00 p.m.

2. WORKSHOP DISCUSSION:

2.A. 2017-795 Downtown Parking

Mayor Schultz called on Ms. Linda Zartler, Assistant City Manager. Ms. Zartler displayed various locations where parking is available in the Hill Country Mile 2000 public/private spaces area. There are approximately parking available. Ms. Zartler stated that most of the property owners have been approached but not all are cooperative. Mayor Schultz stated that he will be meeting with Judge Lux and parking issues is on the agenda. Mr. Jeff Thompson, Deputy City Manager stated that he has met with the County Engineer and it appears the County is positive about a joint venture. Discussion ensued regarding a parking garage, signage, possible bond issue, and the only time parking seems to be a big issue is when there are special events held around the Plaza.

2.B. 2017-796 Convention and Visitors Bureau Facility

Schultz called on Mr. Woods, Convention Visitors Mayor Larry and Bureau previous City Council meeting, Director. Αt Council Member Boyd IV asked for an additional discussion regarding the new Convention and Visitors Bureau (CVB) facility to be located on the Lohman Street parking lot and whether the to include a private/public building should be one or two story Discussions ensued regarding the City being in the landlord business, footage of the proposed building, and concerns with a larger building taking up much needed parking spaces.

2.C. 2017-786 Feeding of Waterfowl in City Parks

Mayor Schultz called on Danny Zincke, Community Services Director. Mr. Zincke asked the City Council for direction on feeding the waterfowl in City Parks. an effort to reduce the number of birds at the River Road Park, about five years signs were posted along the curb asking the public to not feed the waterfowl. Mr. Zincke explained that not only is feeding the waterfowl unhealthy for the birds, but it also creates other issues inside the park and in Discussion ensued regarding moving the signs closer to the edge the roadway. of the fishing pier, providing an educational panel that will educate the public watching instead of feeding birds. provide encourage bird the and educational information on social media.

2.D. 2017-803 Storm Water Utilities/ Drainage Fees

called on Mr. Jeff Thompson, Deputy City Manager and **Public** Mayor Schultz Works Director Mike Mann. Mr. Thompson referred to а newspaper article the City Council regarding San Antonio's modifications provided to their utility fees. Mann reviewed the process storm water Mr. in setting up a drainage utility fund. Discussion ensued regarding having discretion with more incentives for capturing drainage fees than impact fees, rain water, limitation

to just drainage projects, not everyone may benefit, impact and cost of flood events. City Manager Ron Bowman stated that the City continues to be good stewards of funds and the overall quality of life for the community. Mayor Schultz asked Staff to move forward with a consultant.

2.E. 2017-801 Roadway Impact Fees

Mr. Mann continued with the pros and cons of Roadway Impact Fees. These impact fees are restricted to city limits and are paid by the developer during new construction and used forspecific projects. Discussion ensued regarding the concerns with impact fees being passed on to the cost of the new home defeats low cost housing, impact should be on the new and not current taxpayers, and the possibility of waiving the fee if a property is developed in such a way. Deputy City Manager Jeff Thompson referred to study done by Kimley Horn for the City of Seguin. Mayor Schultz asked staff to bring back an example of roadway impact fee and how it will benefit Boerne.

2.F. 2017-787 Parkland Dedication and Park Impact/Improvement Fees

Schultz called on Mr. Danny Zincke, Community Services Mr. Zincke stated that during the update of the City of Boerne Parks, Master Plan, it was recommended that the City consider and Open Space reviewing and updating the current parkland dedication ordinances. Schultz that Staff move forward with the asked recommendation updating the current ordinances and bring back to City Council at a later date for consideration.

2.G. 2017-811 Staff Initiatives Concerning Low Impact Development and LED Lighting

Mayor Schultz called on Ms. Laura Talley, Planning and Community Development Director. Ms. Talley stated that Staff recently attended the Hill Alliance Dark Conference and has also consulted Country Sky with lighting experts. Staff is making preparations to update the current zoning ordinance regarding permit LED Discussion ensued motion lighting. detecting lighting Mr. Talley also spoke on Low Impact Development (LID). in parking lots. Staff is establishing a map, identifying sensitive areas around Boerne. Citv Manager Ron Bowman asked Staff to move forward and hire an expert.

2.H. <u>2017-812</u> Applying an Overlay District to the North portion of Herff Road (Herff Road from River Road to Old San Antonio Road.)

Mayor Schultz stated this agenda item will be discussed at the end of the regular meeting agenda.

1. CALL TO ORDER - 6:00 PM

Mayor Schultz called the City Council meeting to order at 6:00 p.m.

Mayor Schultz asked for a Moment of Silence and led the Pledge of Allegiance to the United States Flag and to the Texas Flag.

2. CONFLICTS OF INTEREST

Council Member Colvin and Council Member Cisneros stated they will recuse themselves from the discussion on Agenda Item 5.A.

3. PUBLIC COMMENTS:

J P Greve, 457 Menger Springs spoke on the sign application for Buc-ee's. He and his wife object to the elevation and the light of the sign.

Chris Hammack, 449 Menger Springs stated he was not in favor of Buc-ee's. He doesn't want Boerne to be like San Antonio adding light pollution and visual distraction.

Joseph Macaluso, 317 Menger Springs spoke against the proposed Buc-ee's sign. He sent a drone shot to the City Council showing that the top of the sign would be seen from the entire subdivision and should be lower since it is on top of a hill. Mr. Macaluso stated that the City Council should not pass the variance.

Steve Kerr, 148 Bitter Springs stated that he is a current member of Historic Landmark Commission. He is opposed to the Buc-ee's sign and feels that the City Council would be opening Pandora's Box if approved. He suggested that the City Council vote no or table the request and visit with the Menger Springs residents.

Ann Dieter, 106 Green Meadows suggested the City Council pursue LID and protect all the creeks in Boerne and the City Lake.

Shawn Berry, 619 Menger Springs spoke against Buc-ee's and expressed concern with home values.

Karan Jamison, 105 Bitter Springs stated that her property will be at the foothill of Buc-ee's and will be looking up at the Buc-ee's sign. She is concerned with water runoff, property tax increase, and opposes the variance and Buc-ee's in general.

Cheryl Ladd, 157 Bitter Springs expressed concern with the Buc-ee's sign. Since Boerne she has seen growth and expected progress. When she purchased her home she thought she would always have а peaceful neighborhood.

Tamara Thornton, 627 Menger Springs stated she recently moved from Katy. She spoke on the elevation of the Buc-ee's location. She is not opposed to growth but it should be done responsibly. Boerne should be a destination that people will remember. She is opposed to the variance.

Anthony Howell, 365 Menger Springs opposed the Buc-ee's sign variance. The City Council would be setting a precedence if the variance is approved. Menger Springs is an establish neighborhood with this sign coming after homes have been built. Buc-ee's doesn't need a sign that large.

Dana Mathes, 164 Creek Springs. He stated he has been a Boerne resident for three years. He expressed concerns with the Buc-ee's development. He opposed the sign height as it isn't necessary and isn't attractive.

John Bradshaw, 101 Peach Springs stated he opposed Buc-ee's sign variance. He suggested the City Council weigh the pros and cons. A pro would provide the ability to see the sign from a distance, but a con would be how it effects the neighborhood. He doesn't understand the sign request. A lower sign would not impact Buc-ee's. The tax base for his neighborhood will suffer.

Ms. Talley continued with an update of the Boerne Master Plan. She noted that there is one day left to complete the online survey. She reviewed the results so far. There were 73 attendees at the October 17, 2017 Open House. She reviewed the timeline and stated that we are still on schedule for the Boerne Master Plan to be approved in April. Discussion ensued regarding how the non-residents responses are considered in the survey.

Talley stated that a sign variance request for Buc-ee's has been received. Ms. for 100 feet in height and 490 square feet The sign variance is with 110 square feet for a Boerne identifier. The City's Sign allows 40 feet in height and 100 square feet for a sign located along IH-10. a visibility test (balloon) which was performed participated in Buc-ee's site using a red balloon at various heights. The balloon was viewed at 100 feet. 125 feet. Ms. Talley 40 feet. and stated that she was in Springs Subdivision when the balloon testing was conducted. She was see the balloon at 40 feet. Mr. Stan Beard, director of real estate for Buc-ee's provided a photo of the current Comfort Inn sign which is similar in size. The Comfort Inn sign that they compared to was approved by variance to allow for 100 feet in height and 408 square feet. The sign review committee was in favor

allowing the variance due to visibility issues. Discussion ensued regarding setting precedents if the sign was approved, height of other signs in the area on the interstate, removing the cobranding, signage at the new exit off IH-10, and suggesting doing a balloon test at 75 feet. Mayor Schultz called on Stan provide additional information. Mr. Beard stated that to make the sign work, it needs to be at least 100 feet especially coming from San Antonio. They are willing to compromise on the square footage.
