### 4. 2018-605 BRIEFING REGARDING LIV AT BOERNE SENIOR APARTMENTS

Chairman Schultz called on Assistant Secretary Jeff Thompson. Mr. Thompson provided the history of the formation of the Boerne Public Facility Corporation 210 Development Group, (BPFC) which was approached by now called Alamo DG, to construct a 162-unit Senior apartment project on Shooting Club Road. Mr. Thompson discussed the process for tax credit funding for the project. The city's funding has been reviewed by the financial advisor, Duane Westermann of SAMCO Capital Markets.

Mr. Mark Tolley of Alamo DG stated they have been working on this project since late 2015. They will be recording the plat in the next few weeks and hope to start construction in October. Mr. Tolley provided an overview of the financing. Discussion ensued regarding the apartment's gas water heaters.
