<b>DESCRIPTION</b>	CONSIDER ON SECOND READING ORDINANCE NO. 2018-44; AN ORDINANCE AMENDING THE CODE OF ORDINANCES, CITY OF BOERNE, TEXAS, CHAPTER 16. PARKS AND RECREATION; AND PROVIDING FOR A PENALTY OF NOT MORE THAN \$200 FOR VIOLATION OF ANY PROVISIONS OF THIS ORDINANCE.
<b>STAFF'S RECOMMENDED ACTION (be specific)</b>	Approve on second reading Ordinance No. 2018-44; Amending the Code of Ordinances, Chapter 16. Parks and Recreation and Providing for a penalty of not more than \$200.00 for violation of any provisions of this Ordinance.

<b>SUMMARY</b>	<p>Staff periodically reviews ordinances to make sure they are up to date. During this routine review it was discovered that during the last update to Chapter 16 several sections of the ordinance were inadvertently removed (16-10 through 16-12). The proposed amendments to Ch. 16 include the re-inclusion of those removed sections.</p> <p>The following changes are proposed: (see red lined version attached)</p> <p>16-1 (a) (7) Remove the word Section and replace with <b>Article</b>. This is simply a clerical correction.</p> <p>16-1 (b) (1) Add the words "<b>and trails</b>" for clarification purposes.</p> <p>16-1 (b) (14) <b>The use of metal detector devices while allowed in City of Boerne park properties is limited to surface hunting only. No cutting of vegetation or digging of any hole is allowed on any park property. The use of metal detectors shall not interfere with the use of the park by other people.</b></p> <p>This is a new amendment which mirrors the current procedure that the department follows. This addition will allow for enforcement and issuance of a fine if necessary.</p> <p>16-3 (k) Skate boarding and biking shall be prohibited at <b>Main Plaza and Veteran's Plaza; this shall also pertain to the use of roller skates, in-line skates, scooters, Segway's, electric scooters, electric bikes and other similar modes of transportation.</b></p>

	<p>This amendment is proposed to add clarity to the policy pertaining to the ever-evolving technological innovations in personal transportation. It also adds Main Plaza which is signed already to prevent skateboarding.</p> <p>16-5 - Old Number Nine Trail, Curry Creek Trail, and Cibolo Creek Trail</p> <p>No unauthorized motorized vehicles shall be allowed at any time on any portion of the trail. This includes but is not limited to cars, trucks, motor cycles, golf carts, ATV's, electric scooters and electric bikes.</p> <p>Adds the other trails that have been constructed since the original writing of this portion of the ordinance. Adds language to clarify "motorized vehicles".</p> <p>Section 16-10 through 16-12 is being added back into the ordinance after being inadvertently being removed during the last amendment to Chapter 16. This section was also reviewed for any needed clarifications or changes and the following changes are being proposed.</p> <p>16-10.14.(H) (a) Any person wishing to sponsor a special event shall apply for a special event permit by filing an application with the City Parks &amp; Recreation Department thirty days prior to the date on which the event is to occur and approval must be granted prior to any advertising of the event can occur.</p> <p>This clarification is being added to match policy and allow for enforcement. It can cause major problems when an event advertises something that does not get approved.</p>
