SUMMARY	<ul> <li>This report addresses the signs at 11 and 15 Herff Road (See report for 7 and 9 Herff Road). The developer is requesting variances to the following requirements: <ul> <li>The 200 feet separation distance; and</li> <li>The maximum sign height of 5-feet. The proposed sign height is 9-feet.</li> </ul> </li> <li>The signs also serve as entrance features to each entrance to the development. As the definition states, the sign shall contain the name of the commercial complex and shall not advertise for individual establishments. This is an important aspect for continuity of the users who arrive at this destination.</li> <li>The requested variances are not an extreme deviation from the code.
