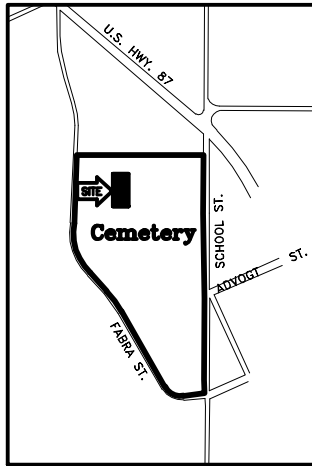

(not to scale)

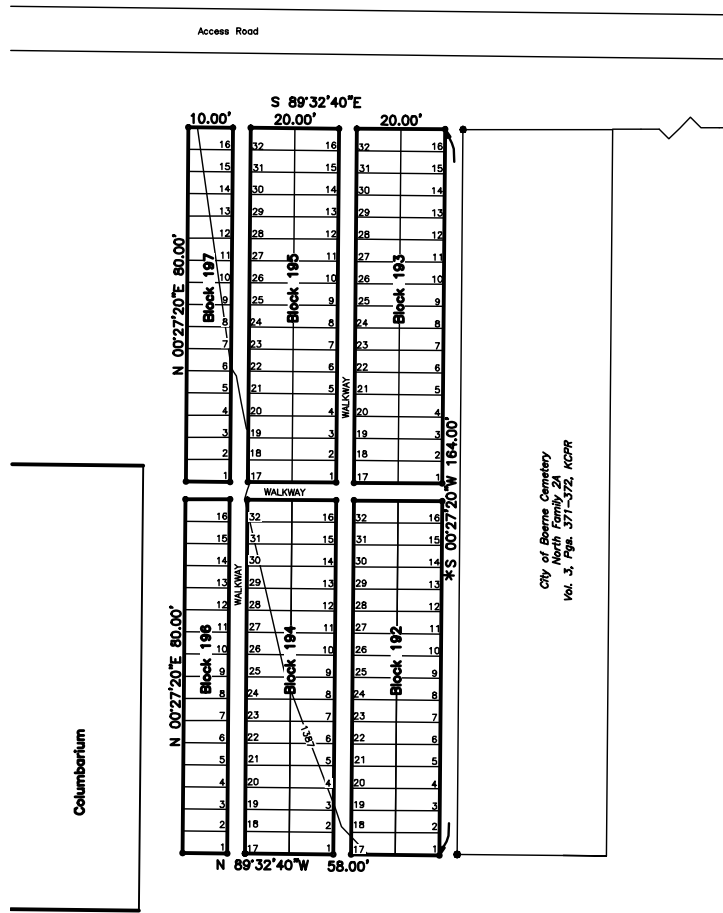

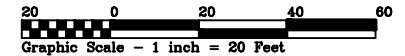
