WHEREAS, the Warranty Deed was recorded in Volume 1543, Pages 185-192 of the Real Property Records, Kendall County, Texas; and

WHEREAS, the Warranty Deed describes the Utilities Easement as 0.694 acre (30,212 square feet) and located in the John Small Survey No. 183, Abstract No. 441, City of Boerne, Texas;

WHEREAS, City no longer has any use for this Utilities Easement and seeks to abandon and terminate same; and

WHEREAS, the City Council of the City of Boerne, Texas, has determined that the Utility Easement is no longer necessary or desired and should be abandoned and terminated.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BOERNE, TEXAS:
