For A  
1.28 Acre Tract of Land**

Being 1.28 acres of land situated in the M. I. Leal Survey No. 180, Abstract No. 298, Kendall County, Texas, recorded in Volume 1320, Page 154, Official Records of Kendall County, Texas; said 1.28 acre tract being more particularly described as follows:

**BEGINNING** at a point located on the east right-of-way line of Sharon Drive West; said point being the common most westerly corner of the said 1.28 acre tract and of a 1.220 acre tract recorded in Volume 1526, Page 624, Official Records of Kendall County, Texas; said point also being the southwest corner of the tract herein described;

Thence N 00°35'28" E, 115.85 feet along the said east right-of-way line to a point being the common most westerly corner of the said 1.28 acre tract and of a 2.494 acre tract recorded in Volume 1610, Page 1054, Official Records of Kendall County, Texas; said point also being the northwest corner of the tract herein described;

Thence S 89°27'04" E, 470.53 feet departing the said east right-of-way line and along the common line between the said 1.28 acre tract and the said 2.494 acre tract to a point being the common corner of the said 1.28 acre tract, of the said 2.494 acre tract, of a 2.500 acre tract recorded in Volume 1225, Page 901, Official Records of Kendall County, Texas, and of a 2.51 acre tract recorded in Volume 1477, Page 441, Official Records of Kendall County, Texas; said point also being the northeast corner of the tract herein described;

Thence S 00°41'34" W, 121.41 feet departing the said common line and along the common line between the said 1.28 acre tract and along the said 2.51 acre tract to a point being the common corner of the said 1.28 acre tract, of the said 2.51 acre tract, and of the said 1.220 acre tract; said point also being the southeast corner of the tract herein described;

Thence N 88°46'26" W, 470.34 feet departing the said common line and along the common line between the said 1.28 acre tract and the said 1.220 acre tract to the **POINT OF BEGINNING** and containing 1.28 acres of land, more or less.

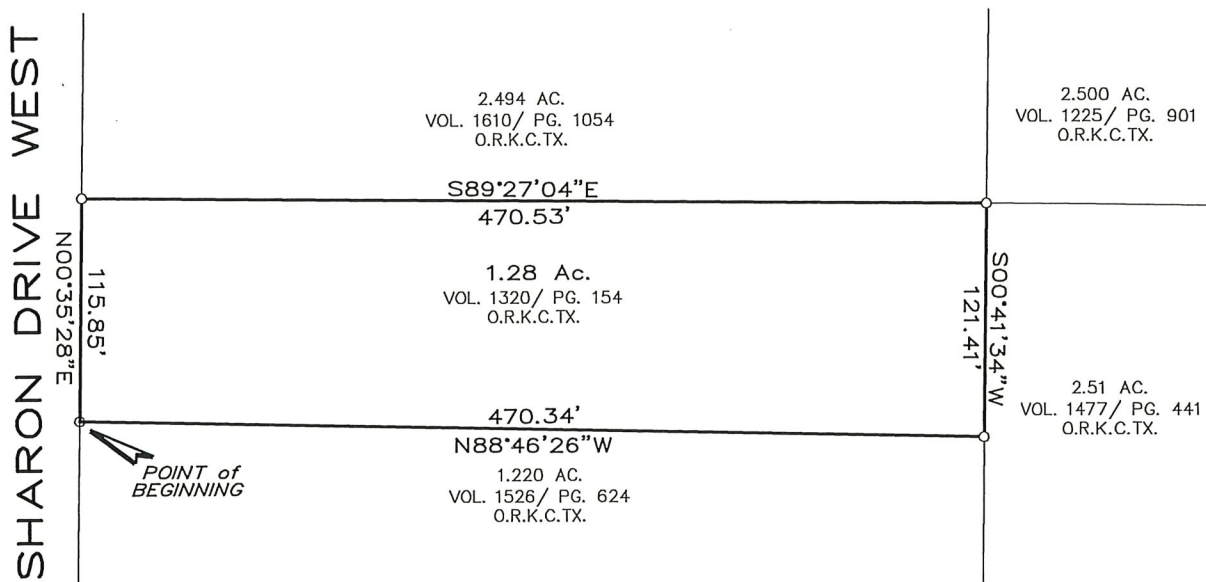
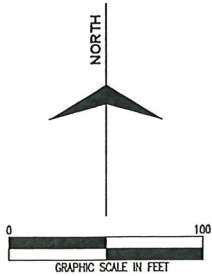
