

**Field Notes
For A
23.13 Acre Tract of Land**

Being 23.13 acres of land recorded in Volume 1646, Page 789, Official Records of Kendall County, Texas, situated in the Nicolas Flores Survey No. 174, Abstract No. 166, Kendall County, Texas, and being out of a 146.831 acre tract recorded in Volume 1431, Page 263, Official Records of Kendall County, Texas; said 23.13 acre tract being more particularly described as follows:

BEGINNING at a point situated on the north right-of-way line of Ranger Creek Road; said point being the common south corner of the said 23.13 acre tract and of a 46.744 acre tract recorded in Volume 1035, Page 350, Official Records of Kendall County, Texas; said point also being the southwest corner of the tract herein described;

Thence N 00°00'57" W, 1016.06 feet departing the said right right-of-way line and along the common line between the said 23.13 acre tract and the said 46.744 acre tract to a point being the common corner of the said 23.13 acre tract, of the said 46.744 acre tract, of a 1.84 acre tract recorded in Volume 1216, Page 1002, Official Records of Kendall County, Texas, and of a 2.0 acre tract recorded in Volume 1431, Page 263, Official Records of Kendall County, Texas; said point also being the northwest corner of the tract herein described;

Thence S 89°47'08" E, 639.56 feet departing the said common line and partially along the common line between the said 23.13 acre tract, the said 2.0 acre tract, and a said 34.9 acre tract recorded in Volume 1431, Page 263, Official Records of Kendall County, Texas, to an angle point being common to the said 23.13 acre tract and the said 34.9 acre tract.

Thence Continuing along said common line, for the following calls:

N 86°01'41" E, 205.47 feet to an angle point;

S 89°47'10" E, 219.14 feet to a point at the beginning of a non-tangent curve to the right;

Along the said non-tangent curve to the right having curve data as follows: Delta of 26°46'52", a radius of 569.00 feet, an arc length of 265.96 feet, a tangent of 135.46 feet, and a chord bearing and distance of S 13°43'27" W, 263.55 feet to a point for the end of this curve;

S 27°07'01" W, 29.46 feet to a point at the beginning of a tangent curve to the left;

Along the said tangent curve to the left having curve data as follows: Delta of 38°22'09", a radius of 430.95 feet, an arc length of 288.59 feet, a tangent of 149.94 feet, and a chord bearing and distance of S 07°55'56" W, 283.23 feet to a point for the end of this curve;

S 11°15'00" E, 148.56 feet to a point at the beginning of a tangent curve to the right;

Along the said tangent curve to the right having curve data as follows: Delta of 11°14'59", a radius of 568.99 feet, an arc length of 111.72 feet, a tangent of 56.04 feet, and a chord bearing and distance of S 05°37'31" E, 111.54 feet to a point for the end of this curve;

S 00°00'00" E, 211.44 feet to a point situated on the said north right-of-way line;

Thence Continuing along the said north right-of-way line for the following calls:


N 89°45'30" W, 277.36 feet to an angle point;

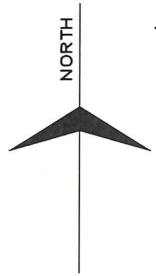
