



**Public Hearing Notice**  
**I-10 from SH 46 to FM 3351 (Ralph Fair Road)**  
**CSJ: 0072-06-082, 0072-07-075**  
**Kendall and Bexar Counties, Texas**

The Texas Department of Transportation (TxDOT) is proposing to expand I-10 from a four-lane highway to an eight-lane highway, from SH 46 to FM 3351 (Ralph Fair Road), a distance just under 10 miles in Kendall County and Bexar County, Texas. This notice advises the public that environmental reports are available for public review and that TxDOT will be conducting a public hearing on the proposed project. The hearing will be held on Wednesday, October 2, 2019 at Boerne Middle School South located at 10 Cascade Cavern, Boerne, TX 78015. Project schematics and displays will be available for viewing at 5:00 p.m., with the public hearing beginning at 6:00 p.m. The purpose of the hearing is to present the planned expansion and to receive public comment on the proposed project.

The proposed project expansion includes adding one new general purpose lane and one new High-Occupancy Vehicle (HOV) lane in each direction. Existing bridges, crossings, and overpasses will also be widened, replaced, or modified to support these improvements. This project is anticipated to take place within the existing right-of-way plan.

Environmental documents or studies, maps showing the project location and design, project schedule, and other information regarding the project are available for viewing Monday through Friday between the hours of 8:00 a.m. and 5:00 p.m. at the TxDOT San Antonio District Office, 4615 NW Loop 410, San Antonio, TX 78229. This information will also be available for inspection at the hearing.
