She displayed information events and photos renovation and expansion of the HUB, a young adult space on the second floor, which was funded by the Boerne Public Library Foundation. Ms. Skovbierg stated that the Friends Book Shop served over 7,000 customers, with total sales of \$34,526 which provides funding for various services for the library. The library also received a \$10,000 grant for a digital media lab. Mr. Thompson explained that in 2015, the City entered into an agreement with Kendall West Utilities (KWU) for the provision of water and sewer outside the City limits. The agreement also prevented Boerne and KWU from encroaching on each other. In 2016, the agreement was amended where KWU could serve in the City's designated service area and vice versa with approval from the other utility. KWU would serve areas where costs were prohibitive for that the amended the City. Mr. Thompson stated agreement under necessary for collection consideration, includes the obligation of franchise fees. KWU's service in the City limits is similar to Bandera and Pedernales Electric Cooperatives service and should be subject to a 4% City of Boerne Franchise Fee.
