Mayor Schultz called on Ms. Laura Talley, **Planning** and Community Talley stated that Ms. the property owner Development Director. requesting property located at the corner of East Highland and Schweppe R-4, Multi-family Residential District. She displayed rezoned a map of location. The owner has stated that they are planning to create a condominium ownership on the lot. A draft site plan was displayed. Ms. Talley mentioned that the owner has recorded deed restrictions with the County that limits the height of the buildings to no more than 2-story and each unit will be provided with a 2-car garage. Staff sent out 15 notifications of the proposed rezoning to surrounding property owners and one response was received in favor of the One person spoke at the Planning and Zoning Commission regarding rezoning. the development who was mainly concerned about property lines. Mayor Schultz called on Mr. Danny Zincke, Community Services Director. Mr. Zincke stated there is an intermittent issue with the traffic light at Old Antonio and Herff Road and it needs to be replaced. The Video (VIVDS) purchased installed Vehicle Detection System was and bν County as part of the Herff Road extension a few years ago. In researching Staff is recommending purchasing a Radar different types of systems, Device (RPDD) system. TxDOT is moving towards the RPDD system because it lasts longer, requires less maintenance, and does not have the same issues with weather that the older VIVDS has. Based on past experience, Staff recommends awarding the bid to SAECO Electric in the amount of \$35,000. Mr. Zincke noted that once the right turn lane is in place at this location, the lights will need to be adjusted.
