Mayor Schultz called the City Council meeting to order at 6:00 p.m.

Mayor Schultz asked for a Moment of Silence and led the Pledge of Allegiance to the United States Flag and the Texas Flag.

3. PUBLIC COMMENTS:

Mike Luckey, 110 Walters Road spoke on the proposed WCID No. 3. He stated that the state of Texas is a property rights state. He supports the landowner and developers right and if the City were to consent to the WCID No. 3, it will give the City control. It could be a win/win for the City and the developer.

Bob Webster, 325 Hwy 46 West and on the Board of Cow Creek Water District spoke on the proposed WCID No. 3. He feels if the City does not consent to the WCID No. 3 and the City gets the message to the State respresentatives it could go away.

Jennifer McCall, 412 West San Antono spoke against the proposed WCID No. 3. She stated that the City and County have known about the WCID for a couple of years, but the public is just now finding out about it. If an agreement is not reached between the City and the Developer, it would go to TCEQ. She stated that the City Council needs to listen to the public's concerns and not listen to relationships with developers.

Phil Bakke, 3511 Broadway Street San Antonio and developer of the property where the proposed WCID No. 3 will be located, stated he is willing to work with the City.

Barwick stated that the construction of the building, it was discovered that an allowance for access control and communications equipment was not included in the overall Boerne Visitors Center budget. With the very minimal project contingency (1%), there is no money in the budget available to fund the needed equipment. The Department contacted three vendors to solicit bids. Two proposals were **GVTC** Texas Electronic **Systems** received, and Specialists, Inc. (TESS). The proposal from TESS was incomplete. Staff's recommendation to accept It was the proposal from GVTC in the amount, not to exceed \$34,323.00. Discussion ensued regarding using the Convention and Visitors Bureau funds and the possibility to get others to bid due to the high cost. I.T. Director explained that time is of the essence and doesn't feel delaying the project was an option.
