Galloway stated that communication to the Mr. community about the new utility will be on social media, the City's website and mailers with the utility bills. Ms. Sandy Mattick, Finance Director stated that Staff met with **SAWS** today to learn their best practices when thev established Stormwater Drainage Utility. Mr. Mann stated that they have been options for offering incentives. He reminded the City Council Members that the first year BISD, Churches, and Kendall County will pay 50% of the fee due to the aggregate of their area. Once the ordinance is passed, it can be "tweeked" before the utility goes into effect in January.

Mayor Schultz called on Ms. Sandy Mattick, Finance Director to review the Second Quarter Financial Reports. Ms. Mattick stated that revenues were 61.82%, expenditures were below above projection at and projections as Sales tax collections were up 8.95% from this period last year. Αd Valorem tax collections were at 97.37%. She continued with the Utility Funds: electric revenues were below 52.28% of budget and expenditures were projections at 37.71%. Water revenues were at 52.62% of budget and expenses below projections at 48.08%. Wastewater revenues were at 50.71% budget and expenses were below projections at 44.87%. Gas revenues were at 67.15% of budget and expenses were able projections at 55.49%. Ms. continued with the Quarterly Investment Report. She stated that the Investment Act requires the investment report to be submitted quarterly During the quarter, the City invested in TexPool, MBIA, to it's governing body. Texas TERM, TexStar, Government Agencies, municipal bonds, commerical treasury notes and several certificates of deposit. paper, Interest earned for quarter totaled \$441,398. Staff will continue to monitor interest activity and act accordingly when opportunities arise.

and Schultz called on Ms. Laura Talley, Planning Community Ms. Talley stated that the Dog & Pony restaurant is under new ownership. Ms. Talley displayed a map of the property as well as photos of the proposed sign. proposed sign will have two components: a fixed advertisement changeable component would advertise and that acts for the music venue. The owners are asking for either a changeable copy sign or a LED sign, both require a variance. Also the size of sign exceeds the permitted

criteria. The request is for 80 square-feet. By ordinance, the maximum square-feet allowed is 64. The changeable part of the sign will only advertise the music schedule and will not advertise for food. Ms. Talley explained that location of the sign has a five to six foot slope from the road, so a monument sign would not be easily seen, also the speed limit is higher at this part of Main Street and a larger sign is easier to see from a distance. She stated that the LED sign will not flash, and will change only once a day. The Sign Review Committee is in support of either the changeable copy or LED sign. Discussion ensued regarding the only LED signs in Boerne are for BISD and concerns were expressed regarding signs brightness and LED. The Keller representative explained that the LED Signs sign can automatically dim at night. It was also discussed that with social media. marquee signs are not as important.
