She stated that there are 107 total properties identified 77 of on the annexation strategy map. those properties were Non-Annexation Agreements, 73 of the agreements have returned signed, and 4 agreements have not been returned. There are 30 total those annexations, 10 of property owners have requested Non-Annexation Agreements and one was offered a Non-Annexation discussed Agreement but would like to be annexed. Ms. Tallev each identified on the Annexation Strategy map. She stated that in Area 14, all the residents Drive have signed the Non-Annexation Agreements. decide which properties would Discussion ensued regarding criteria used to annexed or offered a non-annexation agreement. Ms. Talley explained cost of extending utilities played a factor in the decision as well as the Land there is interest in development, in-fill Use where properties. controlling what goes next to the lake. Discussion continued on determining the zoning for the properties that would be annexed. Ms. Talley stated that in most locations, the Land Use Plan would be used. Ms. Molly Solis, Attorney provided the history behind the Annexation Strategy plan. Due to House Bill 347, the process needed to be expedited. The City no longer can annex property.
