Ms. Mattick continued stating that House Bill 3195 requires the City Council to ratify the property tax revenue increase reflected in the budget to be adopted. She stated that the proposed budget will raise more total property taxes than last year's budget by \$1,134,011 (13.56%) and of that amount, \$539,914 is tax revenue to be raised from new property added to the tax rolls this year.

Mayor Handren called on City Manager Ron Bowman. Mr. Bowman stated that Staff met with Troy Dorman and Jeff Moeller, the City's consultants who, have been contracted to examine the water quality and quantity aspects as it relates and detention/retention. Mayor Handren explained how the Atlas FEMA data would affect the City. The study of rainfall frequency and intensity and Atmospheric Administration published the National Oceanic by increases the flood plain which puts the burden on the developers. Council Member Wolosin stated attended he а local Tea Party organization meeting. Topic of discussion was water. Larry Bailey was present and he discussed the importance of the need for all facets the government to work together.

Mayor Handren stated that the Kendall County Transportation Planning

Steering Committee met last Friday. Rules of engagment were laid out and all members of the committee were identified and they discussed how the group will function. It was decided that all the meetings will be open to the public and notices will be posted.
