written initial assessment from the 2020 Census data was provided to each council member. She introduced Mr. Frank Reilly of Allison, Bass & Magee to discuss the data included in the initial assessment. Mr. Reilly stated that he will do some research to determine the correct population numbers to make sure everyone is identified who completed the census. He stated that other concerns with municipalities have expressed lower population numbers well. Moving forward with the data provided, the total maximum deviation for the Boerne, based the 2020 Census City of upon is 85.18%, therefore redistricting is required. Discussion ensued regarding the projected growth areas, the necessity of Council Members keeping their current seats, suggestion that I-10 not be the separation point between districts. Mayor Handren asked that Mr. Reilly prepare two district maps based on the data he provided for Council's consideration at the December 14, 2021 meeting.
